- (c) It has been reported that the forests in Peddavaram village in the Chmtalapadu Vantu (Muktyala) Estate are private forests belonging to the wife of the Zammdar of Chmtalapadu Vantu (Muktyala) Estate, having been assigned to her by the Zammdar in 1917 and that hence the question of the Government taking them over did not arise. However the question whether the Zamin-darmi is entitled to the grant of a ryotwan patta in respect of these lands has to be determined by the Settlement Officer under the provisions of the Abolition Act

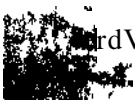
